# **Canoe Polo**

#### **National Canoe Polo**

BD involved in creating the coaching course for Canoe Polo.

**Direct Membership** – MH raised it with PA at the Paddling forum last month. PA have not addressed it so it will be left for Victoria to push it.

WS discussed the issue about members not being members of the State association but membership of another body (ie Lifesaving/ AORCA etc)

Triallist Licensing also needs to be looked at.

Spoke about creating a series of Events for Canoe Polo players? <u>ACTION</u>: Speak to PA / Kate Cohen to look at how nationals was set up in Adelaide. (RM/ MH) Need members to be signed up and who is exactly at the events.

**<u>ACTION:</u>** Proposal to set up a solution for Canoe Polo and how to engage them in Membership.

#### All Abilities (Para) Paddling Funding

MH and SS heading to Yarrawonga Mulwala CC (28<sup>th</sup> and 29<sup>th</sup> May) to speak to Coaches and public and looking at all abilities access. SS has been looking at all abilities access at Bendigo.

VL enquired about our involvement in the LGBTQI+ community.
Gen (comms) did apply for a grant but we didn't receive it.
BD – how do we deal with non gender paddlers?
Polo has mixed teams so gender is not specified. Have the information accessible out in public.
<u>ACTION:</u> VL/ BD speak to Gen (Comms) end of June to promote what PV can do in this space.
